Quantzmed Personal Health (Pty) Ltd trading as Quantumed and hereinafter referred to as “The Company” takes all our clients’ (‘you’ and ‘your’) personal information and the collection, use, security, privacy, and encryption thereof seriously.

This Privacy Policy describes how your personal information is collected, used, shared and protected when you visit our website/s, make a purchase and/or communicate with us in any form, as required by the Protection of Personal Information Act 4 of 2013 (POPIA).

PERSONAL DEVICE INFORMATION THE COMPANY COLLECTS

- When you visit the Company’s website/s, the Company automatically collects certain information about:
 - your device’s make, model and operating system
 - your web browser
 - your geographical location
 - your public IP address
 - your time zone
 - some of the cookies that are installed on your device
- Additionally, as you browse our website/s, the Company collects information about:
 - the individual web pages you view
 - the products that you view
 - what websites and/or search terms referred you to the Company’s website/s
 - how you interact with the Company’s website/s

The abovementioned, automatically collected information, is referred to as “Device Information”.

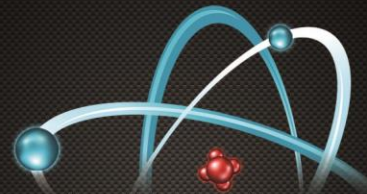
HOW THE COMPANY COLLECTS DEVICE INFORMATION

- The Company collects the aforementioned Device Information using the following technologies:
 - “Cookies” – These are data files that are placed on your device or computer and often include an anonymous unique identifier.

- “Log files” – These track actions occurring on our website/s, and collect data including your:
 - public IP address
 - browser type
 - internet service provider
 - referring/exit pages
 - date/time stamps

“Web beacons,” “tags,” and “pixels” – These are electronic files used to record information about how you browse our website/s.

PERSONAL ORDER INFORMATION THE COMPANY COLLECTS

- When you request a quotation, make a purchase or attempt to make a purchase, the Company will collect certain information from you, this may include your:
 - company name
 - company registration number
 - VAT number
 - physical address
 - postal address
 - email address
 - phone number
 - contact person name
 - other information freely provided by you to Quantumed.

The abovementioned information is referred to as “Order Information”.

When the Company refers “personal information” in this Privacy Policy, the relevant reference is to Device Information and Order Information.

HOW YOUR ORDER INFORMATION IS USED

- The Company uses the Order Information that it collects to:
 - communicate with you
 - provide you with accurate quotes, proforma invoices and/or invoices
 - fulfil any orders placed with Quantumed
 - verify your information by screening our orders for potential risks or fraud
 - protect and defend our rights, property and intellectual property
 - provide you with information or advertising relating to our existing and new products or services which may interest you
- The Company use the Device Information that it collects to:
 - help us screen for potential risk and fraud in particular, your public IP address
 - protect and defend our rights, property and intellectual property
 - improve and optimize our website/s (for example, by generating analytics about how our customers browse and interact with our website/s)
 - assess the success of our marketing and advertising campaigns.

SHARING YOUR PERSONAL INFORMATION

We share your Personal Device Information with third parties to help us use your Personal Device Information, as described above. For example, we use Google Analytics to help us understand how our customers use our website/s. This information is aggregated and cannot be linked to you.

All your personal information is stored on password protected computers with secure firewalls, anti-virus, anti-malware, anti-spyware & ransomware software which is automatically updated daily with the latest security updates.

These computers are only accessible by the Managing Director, Finance Director and Operations & I.T Director of Quantumed, no other party is authorised to access these devices.

EMAIL SECURITY

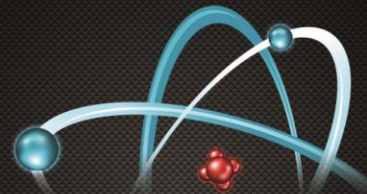
